This is a unique opportunity for a highly motivated person to complete their psychology internship program, in a fully supportive environment where there is dedicated time to complete AHPRA competency requirements. Supervision is provided as part of the employment package. You will have a growth mindset and value supporting vulnerable people to achieve quality health and social outcomes.

- Facilitate a range of individual and group evidence-based cognitive behavioural interventions to clients of BUSY Health, within scope of practice
- Administer a range of psychological assessments (e.g. WAIS, WMS, vocational and educational) to clients
 of BUSY Health, within scope of practice
- Engage in reflective supervision in line with AHPRA requirements
- Engage in contextual ethical reasoning with the goal of achieving clinical competence
- Actively participate in continuing professional development activities including clinical support and quality review feedback sessions, supervision and team member development activities
- Work closely with community agencies to connect people with cultural, recreation, social and education services to create opportunities for clients to meaningfully participate and engage with their communities
- Keep abreast of current research and practices across a range of therapeutic areas
- Facilitate in-home sessions for NDIS participants, with clinical support and guidance from the Senior Health Practitioner and GM Health
- Case consultation with case managers and/or leaders to facilitate the effective provision of support services to be done either separately to the case manager or jointly, depending on the clinical issues involved
- Actively work to meet individual and team clinical and operational KPIs
- Collaborate with other BUSY staff and managers to promote our new allied health services
- Develop relationships with key internal and external stakeholders, promoting The BUSY Group's suite of products and services to key stakeholders
