## Australian Apprenticeships Incentive System (AAIS)

Under the current AAIS program\*, you may be eligible to attract federal incentives if your employee and business meet the eligibility of the program.

Key Apprenticeship Program (KAP) - New Energy and Housing Construction Cert 3 and above (New and Existing workers)		
<b>Key Apprenticeship Program Employer Incentive</b> The Key Apprenticeship Program is an incentive for employers of Australian Apprentices training towards an occupation in 2 critical sectors - New Energy and Housing Construction. To be eligible the qualification must be Certificate 3 or above with an occupational outcome listed on the Australian Apprenticeship Priority List. *The Employer and Apprentice must complete a declaration within the training contract to confirm business engagement and operation with the relevant KAP sector and the apprentice will be provided with meaningful exposure, experience, and work appropriate to the skill level and/or off the job training.	<b>Full time</b>	Up to <b>\$5,000</b> paid over 2 instalments: <ul style="list-style-type: none"> <li>▪ <b>\$2,000</b> at 6 months</li> <li>▪ <b>\$3,000</b> at 12 months</li> </ul>
	<b>Part time and School-based</b>	Up to <b>\$2,500</b> paid over 2 instalments: <ul style="list-style-type: none"> <li>▪ <b>\$1,000</b> at 6 months</li> <li>▪ <b>\$1,500</b> at 12 months</li> </ul>
Priority Occupations Certificate 3 and Above (New And Existing Workers)		
<b>Priority Hiring Incentive</b> The Priority Hiring Incentive is an incentive for employers of Australian Apprentices training towards Priority Occupations outside of the New Energy and Housing Construction industries and is listed on the Australian Apprenticeship Priority List at a Certificate level 3 or above.	<b>Full time</b>	Up to \$2,500 paid over 2 instalments <ul style="list-style-type: none"> <li>▪ <b>\$1,250</b> at 6 and 12 months</li> </ul>
	<b>Part time and School-based</b>	Up to \$1,250 paid over 2 instalments <ul style="list-style-type: none"> <li>▪ <b>\$625</b> at 6 and 12 months</li> </ul>

<b>Disabled Australian Apprentice Wage Support</b> (Part-time pro-rata according to the hours worked) available to the employer	\$216.07 p/w	<b>Note:</b> To be eligible for Disabled Australian Apprentice Wage Support, employers must not be in receipt of the Priority Hiring Incentive.
<b>Assistance for Tutorial, Mentor and Interpreter Services</b> available to Registered Training Organisations (up to \$5,500 per annum)	\$38.50 p/w
